

**Devon County Council (Various Roads, St Anns Chapel & Bigbury)  
(Restricted Road & 30mph Speed Limit) Order**

Devon County Council make this order in exercise of powers under sections 82, 83, 84, part IV of schedule 9 of the Road Traffic Regulation Act 1984 (“Act”) and of all other enabling powers

1. This order comes into force \_\_\_\_\_ and maybe cited as ‘Devon County Council (Various Roads, St Anns Chapel & Bigbury) (Restricted Road & 30mph Speed Limit) Order’,
2. The length of road specified in schedule 1 is a restricted road for the purpose of section 81 of the Act
3. No person shall drive any motor vehicle at a speed exceeding 30mph on the lengths of road specified in schedule 2
4. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011
5. The County of Devon (Various Roads at St. Anns Chapel and Bigbury) (Restricted Roads) Order 1999 is revoked in its entirety

**Schedule 1                      Restricted Road**

*Road at St Ann’s Chapel in the district of South Hams*

**Hilltop** for its entirety

**Schedule 2                      30mph Speed Limit**

*Lengths of road at St Anns Chapel and Bigbury in the district of South Hams*

*The roads listed below are included for the entire length of the highway*

**B3392 Chapel Cross to ZC249 at Bigbury**

**B3392 Road from St Anns Chapel Cross to Bigbury Green Cross**

**Road behind Old Chapel**

**Road from St Anns Chapel to Holwell Farm**

And the specified lengths of road are listed below:

**B3392, Seven Stones Cross to Chapel Cross**, from its junction with Bullhorn Cross to Chapel Cross Road (C252) to a point 320 metres north-west of that junction

**B3392, Bigbury to Tapfield Cross**, from its junction with Bigbury Green Cross to Bowling Green Cross to a point 40 metres south-east of that junction

**C249, Road from Bigbury Green Cross to Bowling Green Cross**, from its junction with B3392 to a point 25 metres south of its junction with West Park Farm to B3392

**C252, Bullhorn Cross to Chapel Cross Road**, from its junction with the B3392 to a point 127 metres west of its junction with Road behind Old Chapel

**Bowls Cross to B3392**, from its junction with B3392 to a point 160 metres north-east of that junction

**Road from St Anns Chapel heading east to Bowls Cross**, from its junction with the B3392 Seven Stones Cross to Chapel Cross to a point 215 metres south-east of that junction

**West Park Farm to B3392**, from its junction with Road from Bigbury Green Cross to Bowling Green Cross to a point 152 metres south-east of that junction
